Summary to be sent to the WSOHC List Serve</p> <p>Next Step</p> <p>Where to begin & make headway in the current economic climate?</p>	<p>Meeting Facilitated by Uncommon Solutions Robby and Victor. Emphasis consolidated into concentrating on partnerships across professions with an overlay of science based evidence. Moving the plan into action will require a new entity since WSOHC too understaffed and underfunded.</p> <p>Pat suggested the plan did seem to be moving. Patty stated the WSOHC mission and Oral Health Improvement Plan seemed like the same idea. Cyndi stated that it was unrealistic due to lack of manpower and funding for WSOHC to take on the Oral Health Plan.</p> <p>Patty spoke for funding other than grant money and Sean mentioned to be sure to have Solicitation Permit from the Secretary of State if we ask for money outside of the organization. Pat mentioned Federal Funding requires a WA State Oral Health Plan. Sean felt it was fact.</p> <p>Cyndi stated that state funding distributed by the Department of Health to the Local Health Jurisdictions was cut by 10% in the Spring. There is a possibility of additional cuts as well. More to be known at the end of November.</p> <p>Federal Health Reform dictates that all newly enrolled children by 2014 will have to have oral health included in new health insurance plans for children. Joella stated that 100% of Federal funding was uncertain across the board.</p> <p>He will forward new information to WSOHC</p> <p>Sean stated that Christi was in the process of obtaining a WSOHC debit card.</p>

After some discussion it was moved by Pat Brown and second by Patty Plank that WSOHC will approve of a letter being drafted by Pat Brown and Elise Tanner supporting school based oral</p>

		health and dental sealant programs. Completion is slated for the end of November 2010.
